Her work *Imperial Reckoning: The Untold Story of Britain's Gulag in Kenya.*" Elkins, an associate professor of history at Harvard University, spent 10 years researching the torture and murder of thousands of Kenyans in secret prison camps operated by the British government in the 1950's. Elkins was an extraordinary scholar/athlete who continues to reflect the outstanding academic tradition of the Township of Ocean Schools.

Resolved that, in compliance with the guidelines of the Open Public Meetings Act, Chapter 231 of the Public Laws, 1975, the Township of Ocean Board of Education hereby gives annual notice that until the next reorganization meeting which will be held in the auditorium of the School District Administration Building at 8:00 pm on Tuesday, April 24, 2007 or until further notice is given that:

**Section 1**. The Regular Public Monthly Meetings of the Board are to be held on the third Tuesday of every month in the auditorium of the School District Administration Building, 163 Monmouth Road, Oakhurst, NJ at 8:00 p.m. as follows:

The Work Meetings are to be held on each Tuesday of every month in the Superintendent's office of the School District Administration Building, 163 Monmouth Road, Oakhurst, NJ at 7:30 p.m.

**Section 2**. The annual notice for Township of Ocean Board of Education meetings will be published in the Atlanticville, the Coaster, and the Asbury Park Press, and will be filed with the Municipal Clerk, Township of Ocean and the Village Clerk, Village of Loch Arbour.

**Section 3**. The President of the Board will announce and have placed in the minutes of each meeting a statement indicating that the notice requirement of the law has been satisfied stating the time, place and manner in which the required notice was provided.

**Section 4**. Only emergency meetings as defined by law may be held without complying with the notice requirements of the law.

**Section 5**. The Township of Ocean Board of Education will hold closed meetings only to discuss those matters, which are specifically exempt from the law. Primarily, these closed portions of meetings will involve personnel matters and material, which would constitute an unwarranted invasion of an individual's privacy. Only the twelve types of material listed in the law will be discussed or acted upon in private.

**Section 6**. Before going into closed session, the Board will adopt a resolution indicating the general nature of the subject to be discussed at the closed session and if and when that discussion can be disclosed to the public

**Section 7**. Appropriate minutes will be kept of all meetings including the time and place for the meeting, members present, method of notice of the meeting and the subjects considered. Minutes will be available for public inspection except items, which are specifically exempt from disclosure by law.

**Section 8**. The public's participation in work meetings will be limited to attendance at the meeting, public comment pertaining to any agenda items and obtaining copies of the agendas and minutes. Active participation will be reserved for the monthly public meetings of the Board.

Section 9. This resolution shall take effect immediately.
