Congratulations to **JOCELYN B. SLOAN**, for being recognized as a Semifinalist in the 2006 National Merit Scholarship Program. More than 1.3 million juniors in over 21,000 U.S. high schools entered the 2006 National Merit Program by taking the 2004 Preliminary SAT/National Merit Scholarship qualifying test. **JOCELYN** was one of 16,000 Semifinalists in the 51st Annual National Merit Program.
