SUPERINTENDENTS REPORT – Mr. Lysko

6. Dr. Nancy Richmond and Dr. John Schoener, consultants from the Foundation for Educational Administration, are proving professional development and classroom coaching for Intermediate School Teachers. The purpose of this project is to expand the skills of both general education and

special education teachers using the co-teaching model.

On January 20th, Judie Haynes, Educational Consultant, conducted a professional development program for teachers at the Wayside School. The workshop provided teachers with instructional strategies to support English Language Learners (ELL) within the general education classroom. Topics included 1) myths and facts of ELL students 2) review of second language acquisition principles 3) reading and writing with ELL students 4) assessment and lesson planning 5) vocabulary development/comprehension 6) and communicating with parents.

These activities were supported by federal funding through the No Child Left Behind Act of 2001.
