#### P 6154 TUITION INCOME PRESCHOOL STUDENTS


#### **Tuition Guidelines**

The Township of Ocean Board of Education shall operate a tuition based preschool program for district residents. The following rules shall apply to the payment of tuition for the preschool program:

- A The parent or guardian submit the district preschool application form to the Superintendent or his or her designee requesting admission to the preschool program.
- B. The application shall be submitted by the deadline stated on the application form.
- C. The parent or guardian shall agree to pay the preschool tuition rate set by the Board of Education by April of each school year.
- D. In order to hold placement in the program upon acceptance ten percent of the tuition must be paid by April 15 of the school year when notification was made. This payment will be non-refundable.
  - 1. The balance of the tuition may be paid in total by August 1;
  - 2. Parents/guardians may opt for the school payment plan and the balance of the tuition shall be payable August 1, (fifty percent) and Jan 1 (fifty percent);
  - 3. All tuition payments shall be forwarded to the School Business Administrator/Board Secretary. No student will be enrolled until the first tuition payment is received;
  - 4. If a payment is not received by August 1 the student shall forfeit their space in the preschool program.
- E. Families with several siblings enrolled in the program at the same time would pay a reduced tuition rate for the second child and for the third child established by the Board of Education by April of each school year.

- F. All applicants shall provide proof of residency and meet the eligibility requirements as set forth in Board Policy.
- G. The student shall maintain a satisfactory scholastic record, as well as a satisfactory discipline and attendance record.
- H. Preschool tuition students shall be subject to all Board policies and regulations governing the conduct and behavior.
- I. Preschool applicants shall be offered enrollment as space is available. When the applications exceed the space available the students will be randomly selected by lottery as detailed in Board Policy.
- J. The Board shall consider and approve tuition reduction or waiver for financial hardship on a case by case basis. Families who have financial hardship due to unemployment, minimal employment and individuals meeting the qualifying Federal standards for free and reduced lunch may be considered for tuition reduction or waiver.
